El Chediak Selected for Editorial Internship



Alissar El Chediak, M.D., an Assistant Professor in the Division of Nephrology, has been selected to serve as an Editorial Fellow for *The American Journal of Transplantation* (AJT).

AJT Editorial Fellows work directly with AJT editors and staff to gain experience in the day-to-day steps of peer review and publication through rotation-based training. The fellowship offers an opportunity to network with AJT editors through mentorship and participation in key journal initiatives.

Dr. El Chediak also received the Pancreas Workgroup Champion award from the [Kidney Pancreas Community of Practice](#) (KPCOP). The KPCOP (part of the American Society of Transplantation) is dedicated to advancing knowledge and fostering scientific collaborations among professionals involved in education, research, and patient advocacy to improve the health, safety, and quality of life for kidney and pancreas transplant recipients, as well as living kidney donors. The Pancreas Workgroup is a subgroup within the KPCOP.

“This award was in recognition of Dr. El Chediak’s service to the Kidney Pancreas Community of Practice,” says **Samir M. Parikh, M.D.**, Professor and Chief of the Division of Nephrology. “Over the past year, she has worked with colleagues from different institutions to advocate for pancreas transplantation and increase access to this important treatment modality.”

Dr. El Chediak earned her medical degree at the American University of Beirut, where she also completed internal medicine residency training. She gained advanced training through fellowships in nephrology and transplantation at Vanderbilt University Medical Center in Tennessee.

Faculty, Fellows Present at Annual Diabetes Meeting

Faculty and fellows from the divisions of Endocrinology, Cardiology, Touchstone Diabetes Center, and the Center for Hypothalamic Research participated in numerous panel discussions, symposia, and poster sessions at the American Diabetes Association’s 84th Scientific Sessions, which took place from **June 21 to 24** in Orlando, Florida.

Each year, the conference brings together more than 11,000 attendees to explore the latest scientific findings in diabetes, with more than 200 sessions and 2,000 original research presentations.

Geriatrics COVE Team Makes House Calls for Older People – and Reduces Hospital Readmissions



“With nearly 12 percent of Dallas County residents being 65 or older, a large population in our community is struggling to get the primary and preventive care they need,” writes **Namirah Jamshed, M.D.**, an Associate Professor in the Division of Geriatric Medicine and Program Director of the Geriatric Medicine Fellowship. “As of 2023, 20 percent of adults 65 and older in the U.S. have a disability that interferes with activities of daily living, such as walking, dressing, and independently using the toilet. At the same time, hospital readmissions – getting sent back to the hospital after an illness or surgery – have become a major stressor for patients and health systems.”

In her MedBlog post, Dr. Jamshed describes UTSW's home-based primary care program, Care of the Vulnerable Elderly (COVE), which launched in 2015 to provide ongoing health care and reduce the need for hospital readmission.

“Research suggests that house call programs like COVE could lower hospital readmissions by 21 percent, reduce nursing home use by nearly 90 percent, and save \$2,000 in Medicare costs per patient each year,” she says. “In nine years, COVE has grown from 70 patients to 450, and we are expecting to expand along with the aging population – people 65 and older are the fastest-growing age group in Texas.”

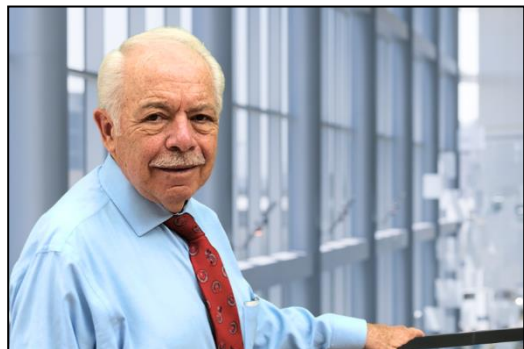

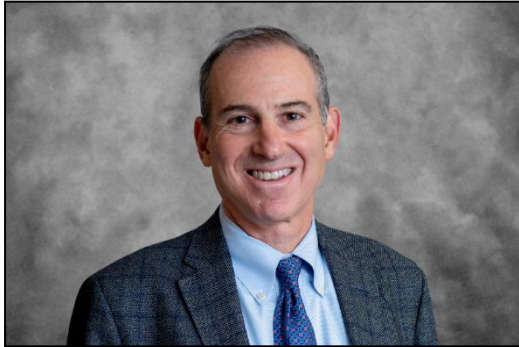
according to SODENN.

Harvard's Steven Grinspoon to Speak about REPRIEVE Trial on June 28



Steven Grinspoon, M.D., a Professor of Medicine in the Division of Nutrition at Harvard Medical School, will present the [Internal Medicine Grand Rounds](#) lecture on 'Friday, June 28, at 8 a.m. in D1.502. His topic: "Cardiovascular Disease Prevention Among PWH in 2024: Lessons from the REPRIEVE Trial."

Dr. Grinspoon earned his medical degree at the University of Rochester School of Medicine. He completed medical residency training at Columbia Presbyterian and a Fellowship in endocrinology at Massachusetts General Hospital.

Dr. Grinspoon also serves as Director of the Nutrition Obesity Research Center at Harvard, and Unit Chief of the Metabolism Unit at Massachusetts General Hospital, where he investigates the neuroendocrine regulation of body composition, and physiologic consequences of fat distribution on cardiovascular disease and inflammation.

Dr. Grinspoon is leading the large multicenter REPRIEVE study, the first study of a primary prevention strategy for cardiovascular disease in HIV.
